

How to insert the card

In order to make a call the tablet requires a SIM Card be inserted.

- Press the card pin into the side hole and then the c ard tray ejects. Pull it out .

- Place the Nano card and/or Memory card into the card tray. Make sure to align the card(s) based on the beveled angle and placed in the correct slot.

- Insert the card tray back into the device.

This device has a non-removable battery

How to boot

Press the power button for 3-5 seconds to boot

How to send SMS, MMS

SMS – Text Message

- Open the Messages app.

- Select Start chat

·In the To Field Enter a tablet number or select one of your contacts.

- Select the Text message field and enter your text.

- Press 🕨 to send your message

MMS – Multimedia Message Service

- When writing a SMS

- Select to attach media to your message, it will automatically convert to an MMS. Select from images, videos or other files to attach them.

Or select to take a new picture or video right away.

- Press **>** to send your message

Language switching settings.

Go to the settings menu by selecting the **Second** Icon. Then select System, then Languages, then System Languages, Finally select Add a language. Find the desired language.

The system will automatically revert back to the Languages menu.

. Select the elanguage and drag it to the desired place to order your language list.

• This device is designed and manufactured not to exceed the emission limits for radio frequency (RF) energy exposure.

• This device is in compliance with the Specific Absorption Rate (SAR) for general population or uncontrolled exposure limits (2.0W/kg) specified in Council Recommendation 1999/519 EC and had been tested in accordance with the measurement methods and procedures specified in EN 62209-2:2010+AMD1:2019.

- The highest SAR value for this model tested for use when worn on the body is 1.743W/kg (10 g)
- This device meets RF exposure guidelines when used in the normal position at least 0 mm away from the body.

When a carry case, belt clip or holder is used for body-worn operation, it should not contain metal and should position the product at least 5 mm away from your body. Ensure the above separation distance instructions are followed.

Data transmission is always initiated by software, which is passed down through the MAC, digital and analog baseband, and RF chip. The MAC initiates several special packets. These are the only ways the digital baseband portion will turn on the RF

transmitter, which then turns off at the end of the packet. Therefore, the transmitter will be on only while one of the aforementioned packets is transmitted. In other words, this

device automatically discontinues transmission in case of either absence of information to transmit or operational failure.

Charging and discharging temperature range

The recommended charging and discharging temperature range of this device is 0~40°C.

Optional Accessory Kit Inclusions:

Folio case – The custom-molded protective case securely holds the T30E, while its flip cover conveniently converts to a kickstand supporting 3 possible positions.

Stylus – A precision input tool designed to interact with a device's touchscreen with a conductive tip that mimics a finger's touch. The stylus simplifies tasks like writing, drawing, selecting small items, and navigating menus.

Bluetooth Mouse – Requires 2x AAA batteries (batteries not included). To trigger Bluetooth Pairing mode press and hold the DPI button until the LED Flashes Green. Once paired to a device the mouse will automatically try to reconnect. The mouse goes into a low power stand-by mode after an idle time of approximately 10 minutes. The Mouse has a left and right click button, a scroll wheel and a DPI button. The DPI button changes the cursor speed.

Bluetooth Keyboard – The Bluetooth keyboard is a lightweight, compact, wireless keyboard that connects to your tablet via Bluetooth technology allowing for a more flexible setup. It essentially turns your tablet into a mini-laptop, making tasks like writing emails, creating documents, and taking notes much easier. This Keyboard is charged through the USB-C port located on the side and in close proximity of the power switch. When charging, the Charging light will illuminate, Orange when charging is in progress and turn off when fully charged.

To pair your Keyboard, ensure the power switch is in the "ON" position. Press the Connect button to enable pairing mode, the Bluetooth indicator light will start flashing indicating Pairing mode is active
